

Cuckooing Risk Identification Tool





This tool has been designed to help frontline practitioners identify those at risk of cuckooing victimisation, and to consider if further support or safeguarding referrals are required. Before completing this form, we would advise you read the educational resources that feature in the Preventing & Disrupting Cuckooing Victimisation Practitioner Toolkit.

Risk is dynamic and can change very quickly. It is good practice to review the checklist at regular intervals.

Please note, this tool is not:

- A full risk assessment for children. If risk towards a child is highlighted you should consider what referrals you need to make to obtain a full assessment of the child's situation.
- A substitute for professional curiosity and judgement. The results from the checklist are not a definitive assessment of risk. They should provide you with a structure to inform your judgement and act as prompts for further questioning, analysis and safeguarding.
